### **LIFE TIME WARRANTY**

#### **Binoculars and Spotting Scopes**

MrStarGuy warrants every binocular and spotting scope to be free from defects in materials and workmanship for its usable lifetime. MrStarGuy will repair or replace such product or part thereof which, upon inspection by MrStarGuy, is found to be defective in materials or workmanship. At its option, MrStarGuy will repair or replace the product, or part thereof, found upon inspection by MrStarGuy to be defective, provided the defective part or product is returned to MrStarGuy, freight prepaid, with proof of purchase from an authorized dealer. MrStarGuy Products purchased outside North America, Canada and previous to 1st November 2006 are not included in this warranty.

To take advantage of this warranty, send your binocular or spotting scope, along with a copy of your receipt from an authorized dealer and a check or money order for \$ 25.00 (U.S. dollars) to cover inspection, handling, and shipping. All returns must be accompanied by a written statement setting forth the name, address, and daytime telephone number of the owner, together with a brief description of any claimed defects. Parts or product for which replacement is made shall become the property of MrStarGuy.

MrStarGuy shall use reasonable efforts to repair or replace any product covered by this limited warranty within thirty days of receipt. In the event repair or replacement shall require more than thirty days, MrStarGuy shall notify the customer accordingly. MrStarGuy reserves the right to replace any product which has been discontinued from its product line with a new product of comparable value and function.
